

The February 6, 2019 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order at 7:00 PM by Chairman Tim Hansen.

Tim Hansen, Larry Sterner, Matt Bollinger, Steve Mckonly, Adam Smith and Norma Markle were present.

Others present were Dan Schmidt, Chief Bean, Morton Family, Bill Hilbert, Clair Altland, Ed Strausbaugh, Karen Bollinger, Cody Bollinger, Bob & Sandy Stine, Holly & Brian Seymore and Harry Rinedollar.

Minutes of the January meeting were approved as distributed.

Chief Bean stated they are working on lowering the costs of the Police Department. The department responded to 48 calls in the Township in December. A gun owner workshop will be held for township residents on March 12, 2019 at 6:30 PM at the Police Department. The crime rates have dropped in the areas that the Department serves since 2003.

The Board thanked Terry Frock for his 10 years of service as the citizen member of the Police Board.

Matt Bollinger made a motion to appoint Dan Schmidt as the citizen members of the Police Board, Larry Sterner seconded and Tim Hansen concurred.

Clair Altland asked how the process is going with turning the Water Company over to the Township. He was hold we are waiting to hear from a Attorney on how to proceed and take over the operation of the system.

Holly & Brian Seymore asked when improvements will be made to Locust Road, they were told in the summer. The water drainage along the road needs to be addressed also. They asked that cones be placed at some of the drop off areas.

Kelly McElroy, Cody Bollinger and Karen Bollinger are interested in forming a Recreation Committee and raise funds to have activities at the park for community. They are interested in having a "Glow in the Dark Egg Hunt" sometime in April, with games and prizes. The Board is in favor of this committee. They would also like to see a bridge behind the Fire Company to access the wooded area. They suggested this could be a Eagle Scout project.

The Morton Family was in attendance to observe the meeting and get a general idea how local government works, this was a school project.

Norma Markle read the Zoning Officers Report. There was \$1,041.00 revenue for the month.

Norma Markle read the Planning Commission Report.

Adam Smith reviewed the Engineers Report. Items reviewed were the 670 Gitts Run Road development, bidding of the bridge project on Gitts Run Road, the opening of the drainage pipes by Penn DOT along Route 116 and an update of the ACT 537 Plan.

Steve McKonly will advertise a Public Hearing for March 6, 2019 at 6:30 PM for the rezoning of some of Gitts Run Road from Industrial to Ag.

Bids for Garbage collection will be received and opened at the March 6, 2019 meeting.

Dan Schmidt suggested that the Township join the NEXT DOOR Community Network, it is free to join.
