The February 7, 2018 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order by Chairman Tim Hansen at 7:00 PM.

Tim Hansen, Larry Sterner, Matt Bollinger, Steve McKonly, Adam Smith and Norma Markle were present.

Others present were Kelly Altland, J. T. Hand, Richard Shaffer, Rick Shaffer, Bill Hilbert, Clair Altalnd, Chief Bean and Scott Rabenstine.

Minutes of the January meeting were approved as presented.

Chief Bean stated that the number of calls were down and will be checking into speed issues on Menges Mills and Old Hanover Roads.

Scott Rabenstine presented the January Fire Reports, there were 18 calls for the month.

J. T. Hand, from York Water Company, stated he was contacted by members of the Heidelberg Water Company concerning what could be done to "get out of the water business." Mr. Hand stated that York Water could run a line along Route 116 for this connection or they could operate a satellite system, this would all need to be approved by the PUC and approved by the Supervisors. This system serves 30 homes and is currently run by residents of the area. The well is located at the end of Longview Drive W, on the Bowersox property. After a very lengthy discussion, Tim Hansen stated that the Township will look into some options for this system and visit the sight and will study what is best for all in this matter.

Norma Markle read the January Planning Commission report.

Norma Markle read the Zoning Officers report, there was 1 permit issued and a Zoning Hearing request, for a total of \$575.00 revenue for the month. The Board asked that Norma check into licenses or fees to run a junkyard in other municipalities.

Adam Smith stated the emergency plan for Glatco Lodge was presented. Gitts Run Road weight restriction ordinance will be prepared for adoption at the March meeting. DEP has issued a waiver for the MS4 permit. The Act 537 Plan is moving forward.

Matt Bollinger stated that the police department is still trying to iron out a contract.

Larry Sterner stated that the road crew is trying to keep the roads in good shape.

The Supervisors agreed to opt in for Penn Waste, Inc. 1 year extension to their contract.

A letter will be sent to the York County Rail Trail Authority stating that the Township is in favor of the trail by using the rail road that is currently not in use.

A bill was received from Rettew, for the ACT 537 Plan, Norma was told to pay \$400.00 of this bill.

Norma Markle was appointed as the Flood Plain Administrator.

Norma Markle presented the Treasures Report.
