- Mack dump truck is or will be back very soon from frame blasting and recoating to prevent further salt damage. This will come out of the Covid fund

- Update on storm damage from Debbie- trees were cleared from roads throughout the Township and storm drains were checked as frequently as other problems would allow. It should be noted that the storm drains do work with the exception of a few, and we are aware of those.
- A log jam developed in Oil creek along Sycamore Drive, and we are in the process of removing it. The resulting flooding washed out a portion of the new road surface and severely eroded the creek bank at the edge of the road. We are removing the log jam to prevent further issues and will be applying for a grant from York County Conservation District to cover the cost. We are also in the process of acquiring an emergency permit through DEP to restore and armor the creek bank as well as restore the road surface. We are also applying for grant funding for these expenses with another DGR grant. The York County Conservation District has been a huge help for this event along with Jackson Township who allowed us to use their backhoe.
