Tim Hansen, Larry Sterner, Steve McKonly and Adam Smith were present.

Others present were Kelly Altland, Sandi & Bob Stine, Scott Rabenstine, Mary & Scott Uffelman and a SW Regional Police Officer.

Minutes of the April meeting were approved as presented.

The SW Regional Police Officer presented the April Police Report.

Scott Rabenstine presented the April Fire Report, there were 22 calls for the month. Sandy Stein asked if there was a burn ban currently in the township, Scott replied there is currently not an open fire ban in the township.

Sandy and Bob Stein thanked Larry for the fine job sweeping up the stones on Straw Acres Road

Tim Hansen read the April Planning Commission report.

Adam Smith presented the estimate to replace the superstructure on the Gitts Run Road bridge. Total cost estimate to be \$278,242.50 which includes a 15% contingency based on a recent bid. Engineering shall be 10%-12% of construction costs. Schedule will need approved. It is suggested to bid this winter to possibly get a more competitive cost.

Adams Smith provide an update on the ACT 537 Plan. To date 32 will water tests have been completed. Well testing will resume after Norma returns. The Task Activity Report (TAR) has been approved by DEP. Anticipated submission date is March 31, 2019.

Steve McKonly suggested we update our ordinances to include zones where fireworks can be sold since the state passed a law allowing fireworks sales.

Tim Hansen asked Steve McKonly the status of the rezoning of the Fuhrman farm. Steve said he will start the process in August.

Tim Hansen read a letter stating Alan Bowersox is requesting his property be included in the Ag Security program as of April 2, 2018.

Tim Hansen presented the Treasures Report.

Tim Hansen made a motion to pay the bills, Larry Sterner seconded.

Meeting adjourned at 7:18 PM.
