Minutes of the May meetings were approved as distributed.

Scott Rabenstine read the May Fire Report. They responded to 19 calls for the month.

Jamie Stalcup, Officer in Charge, presented the April Police Report. The Department responded to 66 call in the Township. Larry Sterner questioned the warnings for grass on the road, Jamie stated that it is illegal to blow grass onto roadways. A discussion followed concerning this matter.

Bids were opened for road improvements for Yingling Drive.

After review of the documents Tim Hansen made a motion to award the bid to Shiloh Paving for Option 1, Matt Bollinger seconded and Larry Sterner concurred.

Sandy Stine questioned the Right-of-Way for mowing along roads within the Township, her along with Bob feel that more mowing should be done. It was stated that the Township does not mow along State Roads. They are also concerned about the property on Route 116 and Jacobs Mill Road, Norma will look into this.

Clair Altland and Bill Hilbert asked about the progress with the Water Company. They were told the Township needs to establish a business plan, daily check and working on pricing at this time. Adam asked Clair about the testing process. A Special Meeting needs to be set up with the water company, township, DEP, Steve, Adam and Kern. This meeting will be organized as soon as possible.

Norma Markle read the Planning Commission Report.

Alan Bowersox presented the Sub Division Plan to remove a .9 acre lot that contains the barn along Route 116 from the farm land consisting of over 100 acres. Tim Hansen made a motion to approve this plan, Larry Sterner seconded and Matt Bollinger concurred.

Norma Markle read the Zoning Officers Report. There was \$826.00 revenue for the month.

Adam Smith reviewed the Engineers Report. JVI was low bidder for the Gitts Run Road bridge project. The contract was not signed due to the PIB Loan not being processed yet. Tim Hansen made a motion to conditionally approve this contact pending loan approval, Larry Sterner seconded and Matt Bollinger concurred. Also discussed the rain water problem on the 6500 block of York Road. Adam will prepare and present a sketch plan for review at a later meeting, to discuss what can be done.

A Hazard Mitigation Plan needs to be enacted in order for FEMA monies to be available for the Township in the event of a disaster. Steve McKonly will prepare an Resolution for this for the July meeting.

**ORDINANCE 19-02** was presented to amend the Zoning Map for the rezoning of 7 properties on Gitts Run Road from Industrial to Agricultural District. Tim Hansen made a motion to adopt this Ordinance, Larry Sterner seconded and Matt Bollinger concurred.
