

The June 7, 2017 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order by Chairman Tim Hansen at 7:00 PM.

Tim Hansen, Larry Sterner, Matt Bollinger, Steve McKonly, Adam Smith and Norma Markle were present.

Others present were Donald Myers, Ed Strausbaugh, Kelly Altland, Scott Rabenstine, Bob Molison, Victoria Harzer, Roger Bollinger and Chief Greg Bean.

Minutes of the May meeting were approved as distributed.

Chief Bean stated it was brought to his attention that the traffic enforcement is down. He stated that this is because of the number of hours the Township is over. He is checking into it and hoping to be going in the right direction.

Scott Rabenstine presented the May Fire Report. The Department responded to 10 calls for the month.

Victoria Harzer who resides at 1112 Porters Road asked about the trees that are being trimmed and cut down throughout the Township. She desires to not have her trees cut or removed. She was advised to contact Adams Electric and speak to them.

Ed Strausbaugh asked if the bronze plaque on the bridge on Jacobs Mill Road would be saved.

Norma Markle read the Planning Commission report.

The Bankert plan is still awaiting a deed to be reviewed.

The Krug plan presented has the incorrect bearing system and needs deed access for the salvage yard and cell tower.

Bob Molison presented his revised plan for the add-on lot for his property off of Smith Station Road. A revised deed needs to be reviewed. Tim Hansen made a motion to conditionally approve this plan, pending Planning Commission signatures and deed approved by Steve McKonly. Larry Sterner seconded and Matt Bollinger concurred.

A Non-Building Waiver was presented for the Hunter Plan, and was signed.

A Non-Building Waiver was presented for the Ruhlman Plan and was signed.

Norma Markle read the Zoning Officers report. There was \$1,159.00 revenue for the month.

Adam Smith reviewed the Engineers Report. The Township may be eligible for a waiver of the NPDES permitting requirements for regulating small MS4s. An application may need to be submitted. There are some funding scenarios to address these items being discussed by the YCPC.

The Jacobs Mill Bridge project is now scheduled for September - November 2017.

A letter was received from PA DOT concerning the intersection of Old Hanover and Iron Ridge Roads.

Norma Markle read the Treasures Report.
