

The July 5, 2017 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order by Chairman Tim Hansen at 7:00 PM.

Tim Hansen, Larry Sterner, Steve McKonly, Adam Smith and Norma Markle were present.

Others present were Ed Strausbaugh, Scott Rabenstine, Kris Raubenstine, Steven Jenkins, Scott Krug and Brian Moore.

Minutes of the June meeting were approved with a correction of the Treasures Report ending balance of \$266,015.04, not \$366,025.04.

There was no Police Report presented.

Scott Rabenstine presented the June Fire Report. The Department responded to 7 calls for the month.

Norma Markle read the Planning Commission report.

The Krug was again discussed. Tim Hansen stated the Supervisors have made a motion to sign the plan and will do so after it is signed by the Planning Commission at next weeks meeting. Tim stated to continue the junk yard a Zoning Hearing will be required.

Kris Raubenstine presented the Jesse Ruhlman plan for an add-on to the Huffnagle property on Woodland Drive. Larry Sterner made a motion to approve this plan contingent upon a deed being presented and the Planning Commission's approval, Tim Hansen seconded.

Norma Markle read the Zoning Officers report. There was \$1,244.00 revenue for the month.

Steve Jenkins a resident of Smith Station Road, stated he is having issues with Comcast and questioned our contract with them. The only contract that we have is from 1985 and was with Hanover Cable Co. He feels they are not complying with their agreement. Tim Hansen stated he is not sure how to help in this situation. Steve McKonly will check with Comcast and check with other municipalities.

Norma Markle asked the Board about the use of the former Warehime property on York Road. John Trone is proposing this area as the new sight for Dean's Auto Plaza. The Board suggested that they first check into getting a road occupancy permit from Penn DOT and a Special Exception would be required.

Adam Smith stated that the plan for the improvement to Glatco Lake is still under review by DEP.

Steve McKonly stated he just received the Deed for the Bankert plan and will review it before the Planning Commission meeting.

Norma Markle stated from July 12-20 she will be in and out of the office and from July 21 - 31 she will be away. Sherry Thompson will be checking the messages and the mail.
