The August 1, 2018 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order by Chairman Tim Hansen at 7:00 PM.

Tim Hansen, Larry Sterner, Matt Bollinger, Steve McKonly, Adam Smith and Norma Markle were present.

Others present were Velda Nickell, Clair Altland, Chris Walker, Dan Schmidt, William Hilbert, Clair Bankert, Pat & Rod Shearer and Officer Goodling.

Minutes of the July meeting were approved as presented.

Chris Walker reviewed the July Fire Report. He reported that the department has been keeping busy with all the rain. Engine 53 is now back in service.

Tim told the residents that were present concerning the water company that Steve McKonly has been in touch with Bowersox and is waiting for a reply. Tim will contact Bowersox this month.

Velda Nickell, Administrator for the S/W Regional Police presented the proposed 2019 Budget. The increase is a 2 year increase since the 2018 budget was never adopted. The total budget presented was \$2,049,341.51, with Heidelberg Township's share being \$393,354.88. An increase of about 4.61%. Velda stated she just wanted the Supervisors to be aware of what is going on.

Officer Goodling presented the June Police Report. The department responded to 56 calls in the Township in June.

Norma Markle read the July Planning Commission report.

Norma Markle read the Zoning Officers report, there was \$814.00 revenue for the month.

Adam Smith reviewed the Engineers Report. The Gitts Run Road bridge replacement is estimated to cost \$300,000.00, this project will be bid in early 2019. This project is eligible for the PA Infrastructure Bank loan @ 2.5% for a 10 year loan. Liquid Fuels monies can be used for this project.

Adam presented Norma with another list for possible well samples for the ACT 537 Plan, Norma will be in contact with Anthoney.

Matt Bollinger stated that the pipe is clogged at the park.

Larry Sterner stated that they are working of storm clean up.

Clair Bankert stated that the willow tree on Sycamore Drive needs trimmed and the gutters need to be cleaned out.

The 2018/2019 Winter Agreement from Penn DOT was presented and signed by Larry.

A request was received to install a bench at the park in memory of a loved one. They would be purchasing and installing themselves. The Board stated this could be done.

There was a discussion to trim the trees along Laurel Woods, this may be bid out to a tree trimmer. The residents will be contacted prior to any work being done.

Norma Markle read the Treasures Report.
