1. Call to Order

The January Board of Supervisors' Reorganization meeting for Heidelberg Township was held on Tuesday, January 2, 2024, at Porters Fire Company. The meeting was called to order at 6:01PM pm by Chairman Tim Hansen. Those present:

2. Pledge of Allegiance

The Pledge of Allegiance was recited.

3. Acknowledgment of a quorum

4. Public Comment

Larry Rohrbaugh, Hoff Road, discussed his years of service in the community and questioned why he was not reinstated on the Planning Commission upon his term ending in 2023

Kathy Rohrbaugh, Hoff Road, discussed/listed Larry Rohrbaugh's service/dedication to the community and his various volunteer efforts.

Sandy Stine, Straw Acres Road, discussed a request for the next newsletter to include a reminder that dogs are to be leashed in the park and also suggested an improvement be made to the quality of the Zoom meetings to make it easier to hear
