Minutes of the October meeting were approved as presented.

There were no officers present to give a Police Report.

Scott Rabenstine reviewed the October Fire Report. The Department responded to 19 calls for the month. Amy Taylor stated that the Truck-or-Treat was a great success and already looking forward to next year.

David Wickham presented copies of properties along Gitts Run Road that are all residential, but are in an Industrial District. Mr. Wickham has presented a petition signed by these residents stating that they are in favor of changing this to a Residential District. Mr. Wickham also stated that Penn Township may be willing to change their zoning across the street to Residential if we do so. There would still be an Industrial District to the south, on Gitts Run Road. Mr. Wickham asked that Board to take a look at this and see what options are there.

Allen Myers asked about a Fireworks Ordinance. He was told that one is being drafted and that it may be adopted next month. Matt Bollinger stated that ATF has been involved with the property owners on Marburg Road causing the fireworks issues.

Steve McKonly stated that he is working on the Sales Agreement for Bowersox for the water system.

Norma Markle read the Zoning Officers report, there was \$50.00 revenue for the month.

Adam Smith reviewed the Engineers Report. Adam will review the Donald Weaver SWMP to see if the bond can be released. The PIB loan paperwork for the Gitts Run Road bridge project is ready to submit, this will need to be signed. Adam met with Kate Klunk and representatives from Penn DOT concerning the flooding on Route 116 causing a public safety issue. The ACT 537 Plan is proceeding with DEP and the well water samples have been completed.

A Worksession will be held on Monday December 3, 2018 @ 7:00 PM to discuss the Water Company and ACT 537 Plan.

Steve McKonly stated that the he will be processing the liens for mowing the property in Porters.

The 2019 Treasures Bond was presented and signed.

The 2019 Budget was presented, the total is \$1,200,000.00, no tax increase. The Budget will be advertised and adopted at a Special Meeting on Wednesday, December 19, 2018 at 7:00 PM.

A request was received by Alan Bowersox, and presented at the May 2, 2018 meeting, to put their 174.163 acres in the Agricultural Security District. This application and was held for 6 months so it can now be added to the ASD of the Township. This will be forwarded to the County.

Norma Markle read the Treasures Report.
