### Heidelberg Township York County, PA Board of Supervisors' Meeting

September 7, 2022

#### 1. Call to Order

The monthly Board of Supervisors' meeting for Heidelberg Township was held on September 7, 2022 at Porters Fire Company. The meeting was called to order at 7:15pm by Chairman Tim Hansen.

### 3. Public Comment

### 4. Approval of August Minutes

Chairmen Tim Hansen made a motion to approve the August minutes. Supervisor Paul King seconded. VOTE 3-0. Motion passes.

Supervisor Paul King made a motion to donate \$800 to the Trunk or Treat event at Porters Fire Company. Vice Chairman Matt Bollinger seconded. VOTE 3-0 Motion passes.

# a. Engineer - Adam Smith, C.S. Davidson, Inc.

Gave an update on 2022 roadwork. Such as, Gitts Run Road chip seal will be fixed by contractor due to delamination. Additionally, he is in contact with PennDot on other repairs for Gitts Run Rd due to an unauthorized detour. MS4 waiver was renewed for 5 years. Adam spoke about next steps for the water company well, which will be to meet with a well driller for water system improvements.

#### i. Cable Franchise Agreement Hearing Announcement

Cable Franchise Hearing to be before the next Board of Supervisors' meeting on October 5<sup>th</sup>. The hearing is to hear from the public with issues they have with current provider and what the resident's future cable needs may be.

#### ii. Amended Fee Resolution 22-6

This resolution amends the current fee schedule resolution 22-3. It adds township building permit fees, rec park usage fees, and administrative fees.

#### iii. SWM Resolution Adopting the Simplified Approach: Resolution 22-7

This resolution adopts a methodology for dealing with stormwater in a manner that is less comprehensive than major land development activities.

Supervisor Paul King made a motion to adopt Resolution 22-7. Vice Chairman Matt Bollinger seconded. VOTE 3-0. Motion passes.

#### iv. EMA- Intergovernmental Agreement

Chairman Tim Hansen made a motion to have the Solicitor review the intergovernmental agreement and prepare a resolution. Supervisor Paul King seconded. VOTE 3-0. Motion passes.

### c. Chairman Tim Hansen

#### i. Advertising for Administrative Assistant Position

The position will work 20 hours per week. This will be advertised in various locations.

Vice Chairman Matt Bollinger made a motion advertise to hire an Administrative Assistant. Supervisor Paul King seconded. VOTE 3-0. Motion passes.

#### ii. Discontinue Zoom for Board of Supervisors' Meeting

Zoom will continue for Board of Supervisors' Meetings.

# d. Vice Chairman Matt Bollinger

### i. Approve 2023 MMO Heidelberg Police Pension Plan

The pension is currently in a surplus and no contribution is needed from Heidelberg Township.

Chairman Tim Hansen made a motion to submit the MMO to the PA Municipal Retirement System. Supervisor Paul King seconded. VOTE 3-0. Motion passes.

#### ii. Hire Professional Services for Water Company

Next steps for the water company well are to consult with a geologist and well driller expert to see if there is enough property for a second well. Reichart Well Drilling has been contacted.

Supervisor Paul King requested Quality Water Resources be contacted on status of the Emergency Operations Manual status.

### iii. Tax Relief for Volunteer Firefighters Discussion

Neighboring municipalities are offering incentives to their volunteer fire fighters. Vice Chairman asked the Solicitor to find more information on the topic and can have further discussion at a later date.

### e. Supervisor Paul King

### i. Park Usage Agreement: Vote for Solicitor Review

Supervisor Paul King made a motion for the Solicitor to review the Park Usage Agreement for the Rec Park Fields. Chairman Tim Hansen seconded. VOTE 2-0. Matt Bollinger abstained due to not seeing sample in email. Motion passes.

### ii. Bridge Loan Payment \$78,000 Liquid Fuels Account

Supervisor Paul King made a motion to pay \$78,000 from the Liquid Fuels account towards the Bridge Loan. Vice Chairman Matt Bollinger seconded. VOTE 3-0. Motion passes.

#### iii. Road Report

Roading sweeping to be done on the roads that were tar and chipped the week of September 19<sup>th</sup>. Vice Chairman Matt Bollinger clarified concerns as to why tar and chipping was done to a newly paved road. That being that the pavement laid was only a leveling course and it needed to be sealed with the tar and chip to prevent water seepage in the winter, that would cause cracking.

Upcoming road work will be guttering along Trolley Road and Porters Road. Also, a pipe replacement on Locust Road and Hoff Road.

#### iv. COVID Relief -ARPA Spending

Supervisor Paul King made a motion that all park expenses (no salaries) until the end of the year; SEK 2021 Audit; Water Company Expenses (no salaries)' Road Sweeping by Outdoor Contractors; and \$1,000 Boy Scout donation be spent from the ARPA Fund. Chairman Tim Hansen seconded. VOTE 3-0. Motion passes.

#### v. Rec Park Report

There has been no playground audit report submitted at this time. Supervisor Paul King has been researching playground equipment grants for when the report comes in to take care of necessary improvements and corrections.

### vi. Children's Game Day

Heidelberg Township will be hosting a Free Children's Game Day on September 24, 2022 12pm- 4pm. Which will include games, prizes, bounce house, and various other activities. Jack Heffner with Spring Grove EMS will be selling food at the Snack Shack.

Vice Chairman Matt Bollinger made a motion to approve \$3,000 for Children's Game Day. Chairman Tim Hansen seconded. VOTE 3-0. Motion passes.
