

The April 4, 2001 meeting of the Heidelberg Township Board of Supervisors was called to order at 7:30 PM at the Heidelberg Township Municipal Building, by Chairman Harry Rodgers.

Harry Rodgers, Guy Brown, Paul Hilbert, LaVerne Becker, Steve McKonly, Dale Myers and Norma Markle were present.

Others present were Kevin Amoss, Dave Shue, Larry Sterner, Sam Myers, Merle Messinger, Pat Carey, Bob Finke, Tim Hansen, Charles Howard and Gary Martin.

Minutes of the March meeting were approved as distributed.

Larry Sterner read a letter from Paul VanNoord concerning the Gitts Run Road improvements. Mr. VanNoord stated in his letter that he feels;

1. Road work was done in Penn Twp.
2. No authority to do work in Penn Twp.
3. This work was not mentioned in the minutes.
4. No bids were obtained.
5. Twp. may be liable for law suit from Penn Twp.
6. Feels the roadmaster violated township ordinances.
7. Illegal spending of township funds.
8. Contractor had no legal authority to do the job.

Mr. VanNoord requested the Board of Supervisors take the following action;

- A. Suspend the Roadmaster from his duties.
- B. Do not use township funds to pay the bill.
- C. Request that the Roadmaster voluntarily withdraws from voting on any matters until a full investigation is completed.

Larry Sterner questioned the spending of \$36,000.00 on this project without a bid when everything over \$10,000.00 needs to be bid. Harry explained that this was done for emergency purposes because of the condition of the roadway. Guy explained that this road had no base at all and needed 18" of binder at some places and necessitated a concrete pipe and a poured catch basin. Paul Hilbert is concerned about the boundary lines and feel that a survey should be done. Harry Rodgers stated that he supports the roadmasters actions and feels he has done a "super job" and stated that the job was more extensive then what could be forseen.

Norma Markle read the Planning Commission report.

Dave Shue read the Fire Report. There were 13 calls for the month. Charlie Howard stated that a request was made by the Heidelberg School PTO to assist in parking cars at their Spring Fling on May 18, 2001. Paul Hilbert made a motion to approve this request if a letter is received from the PTO. Harry Rodgers seconded, Guy Brown concurred. Guy Brown made a motion to put Marlo Howard on the role as fire police. Paul Hilbert seconded, Harry Rodgers concurred.

Dale Myers read the Police Report. The Department traveled 3,547 miles and had 526 1/2 hours of service for the month.

Dale stated he received the grant monies for the purchase of updating the computer system of the regional department and since the department is not operating at this time the grant money was sent to Heidelberg Township. This money will be deposited in the General Fund of Heidelberg Township and when the regional department is started it will be turned over to that department. Harry Rodgers made a motion to proceed with these updates and this will be into account when the regional department is organized. Guy Brown seconded, Paul Hilbert concurred.

Merle Riley asked the Board where the Township stands at this time with the proposed regional department. He was told that the Articles - of - Agreement are still being discussed and the pension needs to be reviewed more thoroughly to proceed. Merle also questioned if this would be cost effective for the taxpayers.

Norma Markle read the Zoning Officers report. There was \$ 578.00 revenue for the month.

LaVerne Becker stated that he is working on updates to revise the zoning and sub division ordinance. Grant money for bridge work on Gitts Run Road must be in by May 31, 2001.

The Board agreed to drop the proposal for sewer hook-up with Penn Township on Gitts Run Road.

The joint bidding with Hanover Borough for various materials were discussed. Guy Brown made a motion to reject these bids. Harry Rodgers seconded, Paul Hilbert concurred.

Bids for various materials will be opened at the May 2, 2001 meeting.

Steve will start working on a proposed ordinance for mini storage sheds within the Township.

Guy Brown stated that DEP meet with himself and Norma about a problem sewer area in the Township and they are demanding that we do an ACT 537 Plan. A consultant from RCAP will meet with them to discuss the avenues to take to enact this plan.

The Ag Security Area was discussed and there are still some people who would like to be included in this. A public meeting will need to be held for this.

There will be an Open House held at Senator Waugh's York office on 4/26/01.

South Pen Roadrunners requested approval to have a race through some of the Township around the lake in September. The Board feels this is acceptable.

A meeting concerning the West Nile Virus will be held May 1, 2001. Guy Brown will represent the Township.
