

The Heidelberg Township Board of Supervisors meeting was held August 3, 2005 at the municipal building and called to order at 7:30 PM, by Chairman Harry Rodgers.

Harry Rodgers, Larry Sterner, Tim Hansen, Steve McKonly, Lucas Parks and Norma Markle were present.

Others present were Bill Brough, Jack Greene, Paul Hilbert, Kris Raubenstein, Scott Rabenstine and Kevin Amoss.

Minutes of the June 23, 2005 Public Hearing were approved as distributed and the July 6, 2005 Regular Meeting minutes were corrected to read in paragraph 11, Final Subdiviison Plan for Paul King that Harry Rodgers concurred, not Tim Hansen.

Sgt. Jack Greene read the Police Report for June 2005, the Department responded to 72 calls in the Township.

Norma Markle read the Planning Commission Report.

Kris Raubenstein from Worley Surveying, presented the Final Plan for B & D along Gitts Run Road. After reviewing and meeting all requirements, Larry Sterner made a motion to approve this plan, Tim Hansen seconded and Harry Rodgers concurred.

Scott Rabenstine read the Fire Report. The department responded to 24 calls in June.

Norma Markle read the Zoning Officers report. There was \$ 2,694.00 revenue for the month.

Tim Hansen stated the Zoning changes are in a 30 day review period at this time. A tentative date for a Public Hearing was set for August 31, 2005.
