

The August 6, 2014 meeting of the Board of Supervisors of Heidelberg Township was held at the municipal building and called to order by Chairman Tim Hansen at 7:30 PM.

Members present were Tim Hansen, Matt Bollinger, Steve McKonly, John Leen and Norma Markle.

Others present were Clair Bankert, Ed Strausbaugh, Kevin Amoss, Ken Koll, Peg Moulton and Officer Nolan.

Minutes of the July meeting were approved as distributed.

Officer Nolan reviewed the June Police Report.

Ken Koll introduced himself as the new owner of Colonial Valley, along with Kim Yates. He asked the Board if there was anything they needed to get completed before they open the Haunted Mill and Club. He was told that an inspection will need to be done by Commonwealth Code Inspection Service, which he has already started the paperwork on. They plan to open September 26, 2014. It was recommended the Fire Company go through to be familiar with the layout and so forth.

Ed Strausbaugh, a resident of 1580 Jacobs Mill Road since 1983 stated that Penn DOT has done 2 major resurfacing projects in this time frame and both times have increased the volume and speed of the traffic. There is also quite a drop off entering his driveway because of the resurfacing. This has caused some very dangerous problems on this roadway. The bridge was built in 1926 and is concerned of how safe this bridge is with the increased traffic, especially with tractor trailers. It is very dangerous to enter and exit his driveway, as there is a blind spot. There are no signs stating this is a residential district. Feels that 35 MPH is too fast and speed limit should be lowered to 25 MPH. Invited the Board to come and see and witness these conditions. Has experienced many close calls just going to his mailbox. How serious of an accident will need to occur before anything is done, traffic needs to slow down. Improvements need to be made to Trolley Road also, drainage problem, gutters need to be opened. Tim Hansen stated that this is a state road and realizes the traffic is very bad. Tim suggested contacting Chief Bean and patrolling this area more often. We will also check the weight limit for this bridge. Mr. Strausbaugh has spoken to Clint Leekway and Mike Summerville from Penn DOT and stated he is not going to let this rest, he will go to his congressman if necessary.

Tim Hansen stated he will speak to Larry Sterner about opening gutters on Hayrick, Sycamore and Trolley Roads.

Clair Bankert stated Sycamore/Iron Ridge Roads culvert pipe has collapsed. The surface needs to be graded and the gutters need to be opened. Road is washing out. Clair suggested that rumble strips be installed on Old Hanover Road at the curves at Krug's to slow people down.

Peg Moulton stated that large rocks are washing out on to High Rock Road North. Peg also stated she missed the YCRTA meeting here in May and would like to Township to cooperate with the Authority in getting the trail started in the Township.

Norma Markle read the Planning Commission report.

Norma Markle read the Zoning Officers report. There was \$ 1,105.00 revenue for the month.

Kevin Amoss read the Fire Report. The Department responded to 13 calls in July.

John Leen reviewed the Engineers Report.

Steve McKonly will review the 5 year Winter Agreement with Penn DOT and also review the Ag Security map to see if it is accurate.

Matt Bollinger stated the signs for the Park are here and will be installing.

There will be 30 hunting permits given out for the 2014/2015 hunting season at the Park.

Norma Markle read the Treasures Report.
