Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve the 2026 Budget for the General Fund, Water Company, Liquid Fuels and PIB Loan. Supervisor King called for discussion. Motion passed 2-1.

Supervisor King made a motion to amend the motion to increase line 301.20 by \$20,000.00. Motion failed due to lack of a second.

Supervisor King made a motion to amend the motion to increase line 310.21 by \$20,000.00. Motion failed due to lack of a second.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to adopt Ordinance 2025-03, setting Supervisor Compensation for Supervisors entering office after the effective date of the Ordinance. Motion passed 3-0.

Chairman Hansen acknowledged receipt of the letter from York County Planning Commission regarding the Time of Performance extension from December 31, 2025 to June 30, 2026.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve Resolution 2025-14, amending Water System Rates. Motion passed 3-0.

14. Solicitor

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve for advertisement Ordinance 2026-01, speed limit amendments to Ordinance 88-2. Motion passed 3-0.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve for advertisement Ordinance 2026-02, as amended, Cannery Road Vehicle Size Limitation. Motion passed 3-0.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve for advertisement Ordinance 2026-03, Stop Sign at High Rock Road W and High Rock Road N. Motion passed. 3-0.

Vice Chairman Bollinger made a motion, seconded by Chairman Hansen, to table the Resolution to pay Fire Department additional \$59,000.00 before December 31, 2025.

Supervisor King made a motion for a Resolution to be drafted: That the BOS of Heidelberg TWP, in an effort to protect women, acknowledge that the vast majority of Heidelberg TWP Taxpayers don't want their tax \$ associated with an organization that allows or condones, that a male by birth can enter a woman's locker rooms and/or rest rooms. Motion failed due to lack of a second.

Supervisor King made a motion to bring to discussion a tabled motion to: Motion to delay Tar and Chip on Menges Mill and Cannery RD and replace for 2026 Tar and Chip for Thoman Rd from Yingling Rd to 6148 Block of Thoman Rd. the east bound lane only covering the center painted line. Vice Chairman Bollinger stated that the Assistant Road Master had some other ideas to take care of the issue. Motion failed due to lack of a second.

Supervisor King made a motion to bring to discussion tabled motion to: Motion to have the following made into an ordinance or to have them as an amendment to the TWP Zoning Ordinance:

- a. Occupying a Recreational vehicle or camper or tents for more than 15 days in any six-month period is prohibited. A special permit can be issued to extend the time if for the purposes of
 1. Providing health/domestic care to the owner of the property.
 2. A special permit can be issued to extend the time if for the purposes of renovating a house on the same property. The exemption is for the homeowner only
 3. In an agricultural zoning area/district can be granted for farm workers
4. Connecting a Recreational vehicle to the TWP sewer or water system or to a well or septic system of any property owner of the TWP is prohibited.

b. Recreational vehicles and campers legally hooked up to existing sewer or septic systems prior to the passage of these provisions is exempt.

Chairman Hansen stated that we need to review this with the township engineer, in the future we will be reviewing the Zoning Ordinance that supports this. He would like to keep this motion tabled until January. Therefore, motion failed due to lack of a second.
