The December 2, 2009 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order at 7:30 PM by Chairman Harry Rodgers.

Harry Rodgers, Larry Sterner, Tim Hansen, Steve McKonly, Lucas Parkes, Jay Little and Norma Markle were present.

Others present were Brian Banker, Chief Greg Bean and Roger Bollinger.

Minutes of the November 4, 2009 meeting were corrected to state the General Fund beginning balance was \$235,618.68 and were other wise approved.

Chief Bean reviewed the October reports. The police department is involved in the Adopt-A-Road program and collected 10 bags of garbage along Moulstown Road. Chief Bean and Steve Grassitti from Penn DOT met and discussed the Moulstown and Old Hanover Road area which is a major concern to the department. There have been 34 accidents in this area in 1 year. Different ideas were tossed around to help make this road safer. There will be updates concerning this meeting. Larry Sterner asked Chief Bean to check out Deagen Road, there has been alot of 4 wheeling along this road and is causing the road to break.

Roger Bollinger questioned the progress of obtaining the Glatfelter property and realizes donors are needed. Harry Rodgers feels there is not alot of support for this and the Township shouldn't spend any more money on this project.

Street light costs were discussed concerning the 2010 Budget. Harry Rodgers suggested to do away with collecting street light tax. He feels this is a pubic benefit and that only a few people have to pay the tax. Steve McKonly stated this tax could be repealed, but must be done by Ordinance. Steve was asked to have an Ordinance for the January 2010 meeting.

The 2010 Budget was presented, which totals \$875.000.00 and includes a 1.25 millage rate for general purposes and .25 millage rate for the fire company. Tim Hansen made a motion to adopt **RESOLUTION 09-10** to set the millage rate at 1.5 mills, Larry Sterner seconded and Harry Rodgers concurred. Larry Sterner made a motion to adopt **RESOLUTION 09-11** to adopt the 2010 budget, Tim Hansen seconded and Harry Rodgers concurred.

The Board asked Steve McKonly what can be done about the 2008 Audit. He will check into this.

Norma Markle read the Planning Commission report.

Brian Banker read the Fire Report. There were 19 calls for the month.

Jay Little read the Zoning Officers report, there was \$500.00 revenue for the month.

Lucas Parkes reviewed the Engineer's Report.

Norma Markle's 2010 Treasures Bond was presented and signed.

Tim Hansen made a motion to adopt **RESOLUTION 09-12** to increase the Tax Collectors fee for tax certifications to \$20.00 and increase the fee for duplicate bills to \$6.00. Larry Sterner seconded and Harry Rodgers concurred.

Harry Rodgers stated thank you letters were received from Glatfelter Memorial Library, Guthrie/Hanover Library and the VNA for the Township's recent donations.

The next meeting will be Monday January 4, 2010 at 7:30 PM.
