Pam Worley presented a letter of request for a 60 day extension of the Adeline Delaney - Final Subdivision Plan. The Board accepted this request.

Pam presented the sewage modules for the Andy Winebrenner subdivision. Harry Rodgers made a motion to adopt **Resolution 00-08** for this module. Paul Hilbert seconded, Guy Brown concurred.

Pam also presented a letter of approval from DEP regarding the Land Survey, LLC, for Bruce Ruhlman. The Board did not act on this plan at this time due to language in notation #9 on the plan.

LaVerene Becker discussed the sewer hook-up on Gitts Run Road and estimated that it would cost \$ 600.00/year. This would be 130% of Penn Townships rate. The developer would need to install all the lines and pay for administrative fees and costs of meters. LaVerne will be meeting with Jeff Garvick in January.
