Others present were Dirk Wildasin, Lauren Bair, Bob Finke, Bruce Jones, Matt Bollinger, Pam Worley, Bonnie Wineholt, Kevin Amoss, Chris Williams, Jeff Martin, Kathy Jones, and Karen & Jim Ambramczyk.

Minutes of the January meeting were approved as distributed.

Kathy Jone from the Spring Grove Area Community Center gave an update on what activities are taking place at the Community Center and stated that a quarterly newsletter is being sent to Spring Grove Area residents concerning the Center.

Bruce Jones gave an update from the Recreation Board and some of the activities planned. A Basket Bingo will be held March 24, 2002, a Family Fun Day will be held May 18, 2002 at the ball field and in June a lobster feed will be held at Michael's. A & L Fence Co. will be installing a fence for the backstop. Paul Hilbert stated that he would like to have Scott survey the line before any fence is installed and Larry Sterner suggested getting this settled before it goes any further. Steve McKonly suggested doing a sub division reversal of all 3 parcels. The Board would like to see parking for the May 18th event on the upper part of the field and suggested that Scott check on getting a driveway permit from the State to get this started. Bruce stated they are selling banners for the fence and this project is going well.

Kevin Amoss read the Fire Report. There were 29 calls for the month.

Scott DeBell stated that he will work on finding the township property line concerning the recreation area.

Steve McKonly will be sending a letter to Gilda Shearer concerning purchasing the corner lot from her for \$ 5,000.00.

Larry Sterner stated he would like to get the bids for road work out in April. Larry would also like to meet with Scott to inspect the bridge on Woodland Drive.
