Others present were Bruce Jones, Lucas Parks, Brandon Bishard, Curvin Snyder, Kathy Harr, Sgt. Lisa Dixon, Scott Rabenstine, Kevin Amoss, Cal Taylor and Linda Dyches.

Minutes of the January meeting were approved as distributed.

Sgt. Dixon read the Police Report. There were 93 calls in the Township in December 2006.

Bruce Jones presented a proposed 2007 budget for the Recreation Park. Would like to get a well drilled this year.

Garbage Contract to be bid for the March 2007 meeting.

Norma Markle read the Planning Commission report.

Brandon Bishard, from Hanover Land Surveyors, presented a Final Plan for Cal Taylor for a 2 lot subdivision along Locust Road. Curbing will need to be installed when a permit is granted for the vacant lot. A letter of credit will need to be obtained. Installation of sidewalks was waived. John Leen and Lucas Parks reviewed the engineering report. The Gerlack fence and grass leveler have not been installed yet, due to the weather. They are also reviewing the Duracart Plan and what needs to be done to comply.

Lucas Parks reported that a Special Bridge Inspection was held on the Gitts Run Road bridge by the state. The inspection came in above the state level to be repaired or replaced. There was a concern with the large amount of truck traffic.

Steve McKonly stated he reviewed the request from Tim Sterner to sale spring water from his property in Menges Mills. Steve and John both agree that Mr. Sterner should supply the Township with a Land Development Plan for the entire property and therefor suggested the Supervisors reject the plan submitted. Tim Hansen made a motion to reject the proposed plan submitted by Mr. Sterner, Larry Sterner seconded.

Larry Sterner reported the road crew is ready for the winter weather.

Sgt. Dixon reported that the Police Department met with the Group Home on Smith Station Road and were given a layout of the building and list of emergency contacts. They toured the building and saw the alarm systems were inplace and all windows and doors set up on this system. The residents that are living there were not court ordered to be there.
