ORDINANCE NO. 04- 02

AN ORDINANCE REGULATING CONDUCT AND USE OF THE MUNICIPAL PARK IN HEIDELBERG TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AND PRESCRIBING PENALTIES FOR VIOLATION

WHEREAS, the Board of Supervisors of Heidelberg Township believes that to protect the health, safety, and welfare of the residents, regulation is necessary regarding the conduct of individuals in the municipal park and the use of the facilities at the municipal park.

WHEREAS, The Second Class Township Code, Act of May 1, 1933, P.L. 103, No. 69, as amended, 53 P.S. §65101, et seq. specifically, 53 P.S. §67203, authorizes Townships of the Second Class to make regulations by ordinance, relative to the use by the public of parks and recreation grounds and the facilities and amusements connected therewith.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, and it is enacted and ordained, by the Board of Supervisors of Heidelberg Township as follows:

SECTION 1. RULES AND REGULATIONS.

The Board of Supervisors adopts the following as rules and regulations with respect to the municipal park:

Heidelberg Township Rec Park Rules

Please read and abide by the rules as set forth by ordinance.

- a. Park hours to be dawn to dusk.
- b. No pets without leash and waste bag.
- c. No golf practice.
- d. No alcoholic beverages or illegal drugs.
- e. No loud, boisterous or indecent conduct.
- f. No littering.
- g. No vandalism, graffiti or destruction of facilities, structures, or improvements, including the turf and any plantings.
- h. No motorized model airplanes, ATV, or mini bikes.
- i. No skateboards or roller blades.
- j. No open fires.
- k. No firearms, air guns, slingshots, paintball, or explosives.

- l. Speed limit is 15 mph.
- m. No climbing on roof tops of the dugouts or other buildings.
- n. All trash must be put into a proper container.

Reservations for these facilities such as ball fields and pavilions can be made through the township office at 225-6606.

Call 911 if any violation of above rules is witnessed. All violations are punishable by fine and/or imprisonment.

SECTION 2. PENALTIES FOR VIOLATION.

Any person, firm or corporation who shall violate this ordinance shall be subject to the fines and penalties set forth in Ordinance No. 97-2, as it may hereafter be amended.

SECTION 3. SEVERABILITY.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction such portion shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions hereof.

SECTION 4. REPEAL OF INCONSISTENT ORDINANCES.

All ordinances, or parts of ordinances, which are inconsistent herewith, are hereby repealed.

SECTION 5. EFFECTIVE DATE.

This Ordinance shall become effective five (5) days after the adoption hereof.
