#### **INSURANCE REQUIREMENTS**

#### SPECIAL PAYMENT CONSIDERATIONS:

#### **APPENDIX B**

#### HARVESTING -

Residual trees to be **KEPT** are marked with a **YELLOW** band with a dot on the stump. The outside sale boundary lines are painted with three slashes and may not be cut. An inventory cruise was utilized to estimate softwood pulpwood tonnage. <u>Volumes were estimated using a 10</u> BAF prism cruise and are not guaranteed. Bidders should estimate volumes to their own satisfaction.

All due care must be taken by Buyer to minimize damage to those trees that are not designated in this conveyance to be removed. A monetary penalty shall be assessed for excessive damage at the discretion of Owner's Agents, Timber Ridge Forestry, LLC.

Tops shall be kept within the owner's boundaries and shall be cut down to within 4 feet of ground level.

The landing area must be graded, seeded, and mulched. All skid trails shall be graded, and water bars installed at designated areas. All blocks and debris must be removed from the landing area.

Logging equipment must be power washed before moving onto the job site to help prevent the spread of invasive plant species.

Timber Ridge Forestry, LLC will prepare an Erosion Control Plan for the Buyer. 
