Guy Brown made a motion to appoint Harry Rodgers Chairman, Paul Hilbert seconded.

The Zoning Hearing Board will meet the fourth Tuesday of each month as needed. The Supervisors can spend \$ 1,000.00 per month, without Board approval. Guy Brown seconded, Paul Hilbert concurred.

Paul Hilbert seconded, Guy Brown concurred on the pay rates.

Minutes of the December meetings were approved as distributed.

Dirk Wildasin from B & D Development presented a proposed plan for a sub division off of Gitts Run Road. This would require bringing sewer in from Penn Township and also curbing. Mr. Wildasin suggested rolled curbing and that was okayed by the Board. The street would need road frontage. Following a lengthy discussion, Mr. Wildasin will take this plan to Don Worley to complete.

LaVerne Becker stated he is still waiting for the legal discription for the alley way in Porters. Gitts Run Road will be a number 1 priority job though York County Planning in 2000. LaVerne is waiting for a topo map of the proposed recreation area.

216 Norma Markle read the Planning Commission report.

Dave Shue read the Fire Report. They had 19 calls for December and a total of 195 calls for 1999.

Dale Myers read the Police Report. The Department traveled 2,200 miles and had 378 1/2 hours of service for the month. Dale stated the Mario DeVivio was hired on January 3, 2000.

Norma Markle read the Zoning Officers report. There was \$ 474.00 revenue for the month.

Guy Brown stated he is getting bids for a new road sweeper. He also stated they may be interested in purchasing some new equipment this year. The road crew is ready for the snow.

Paul Hilbert stated that the gutters along Cannery Road need to be opened. Guy Brown stated this will be taken care of when they do the work on Rosepointe.

Harry Rodgers read a letter from Pete Soloymos concerning the Sterner case. The Board feels these charges should be filed.

Harry Rodges made a motion to appoint Guy Brown as Representative and Norma Markle as Alternate Representative to the York Area Earned Income Tax Bureau. Paul Hilbert seconded, Guy Brown concurred.

Andy Brough questioned the ball field. Guy Brown explained the sketch plan to him.
