The meeting was opened with the Pledge of Allegiance.

Minutes of the December meeting were approved as distributed.

Tim Hansen welcomed Paul King on board as the newly elected Supervisor.

Paul King thanked Larry Sterner for his 18 years of service as Supervisor to the township and stated that in his 18 months of campaigning he learned how much Larry has contributed to the agricultural community and he has done an excellent job throughout the township.

Phil Smith stated he would like to welcome Paul onboard and thank Scott Rabenstine and Larry for their service to the township. Phil stated that EMA Coordinator Brian Bankert now lives in Adams County and would like to assist in the update of the current EMA Plan.

Sandy Stine asked about the ditch beside their property that causes water issues for them. Adam Smith stated there are grading issues and suggested the culvert & pipe be cleaned out and stone placed. There is a question concerning the right-of-way. Adam has estimated the cost of this being around \$5,000.00. Address this closer to spring, but the pipe could be cleaned out anytime.

Roland Bohrer asked about the flooding issues on Route 116 and if there is any FEMA funding available. Adam stated there has been a request made to the state and there has been no response.

Dan Schmidt discussed his recent water bill and the amount that it had gone up and what is the plan going forward. The Board explained that for years they have basically received FREE SERVICE from the members of the co-op and now we are paying for daily checks and also an operator. New meters will need to be installed that can be scanned and other items will need to be updated. Roland Bohrer stated this was poor planning on behalf of the township for allowing these homes to be built on this system. He was told that when these homes were built there were no permits required to build. Tim Hansen suggested that home owners check for leaks and conserve if they can.

An audience member asked what is going to happen to the Southwester Regional Police building and they were told that Northern Regional Police plan to purchase and have a satellite station.

Scott Rabenstine asked about how many hours of coverage we are receiving from NYCRP, he was told 96 hrs. per week. Scott asked if the police building would be staffed and he was told it would be and also there may be an office rented to the York County Sheriff's Office.

Tara Wentzel stated she lives on Deagen Road and asked if Penn Township or NYCRP would patrol their area. She was told it would be NYCRP and they would be contacted concerning the layout of the area. Mrs. Wentzel also asked about a website for the Township, she stated she saw a post on Next Door and that is why they were attending. Paul King stated he is gathering information for a website.

Shawn Carbaugh stated that face book is easy to manage and it is fee. It was also suggested that a newsletter, filers, nixel or twitter are a good way to communicate to the public. Also suggested advertising our meetings on the billboard of York and Porters Roads.
