

The July 6, 2016 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order by Chairman Tim Hansen at 7:00 PM.

Tim Hansen, Larry Sterner, Steve McKonly, Adam Smith and Norma Markle were present.

Others present were Earl Fuhrman, Kevin Amoss, Ed Strausbaugh and Chief Bean.

Minutes of the June meeting were approved as distributed.

Chief Bean presented the May Police Report. The Department responded to 64 calls in the Township.

Kevin Amoss presented the June Fire Report. The Department responded to 19 calls for the month.

Earl Fuhrman would like to change the zoning of his property from Industrial to Agricultural. He is interested in putting this property in the Ag Preservation Program. Steve McKonly stated a letter will need to be obtained from Mr. Fuhrman requesting this change to get the process started. There would also need to be an amendment to the zoning map.

Ed Strausbaugh suggested the weight limit signs for Menges Mills Road should be placed on Route 116 and Old Hanover Roads before the turns to access. This would save money on the purchase of scales. Ed also stated that a truck ran through the gutter on Trolley Road and seems to have opened it and the water is flowing better.

Norma Markle stated the Planning Commission did not meet in June.

Norma Markle read the Zoning Officers report. There was \$1,608.00 revenue for the month.

Adam Smith reviewed the Engineers Report. The MS4 Plan needs to be adopted by 2017.

Steve McKonly stated that we will need an adequate area for the Industrial Zone if the Fuhrman farm is put back into the Ag District.

A letter was reviewed from York County Planning Commission for the review of the York County 2016 Heritage Preservation Plan. Norma will check with Pam Shellenberger to see if any of this will affect the Township.

We will be checking to see if Amy Way was ever adopted.

Norma asked Steve if there is an outstanding bond for the Lillich/Beckett property on High Rock Road.

Norma Markle read the Treasures Report.
