

The June 6, 2007 Board of Supervisors meeting was held at the Heidelberg Township Municipal Building and called to order at 7:30 PM by Chairman Harry Rodgers.

Members present were Harry Rodgers, Larry Sterner, Tim Hansen, John Leen and Norma Markle.

Others present were Lucas Parkes, Sgt. Jack Greene, Brandon Bishard, Kevin Amoss, Scott Rabenstine, Tim & Cindy Bortner, Curvin Snyder and Peg Moulton.

Minutes of the May meetings were approved as distributed.

Sgt. Jack Green read the April 2007 Police Report. The department responded to 70 calls within the township. Sgt. Greene reported that a speed check was conducted on Mill Road on May 28-31, and it showed that 211 vehicles traveled this road and their average speed was 29 MPH in a 35 MPH zone. He did state that one vehicle was clocked at 55 MPH. Sgt. Green also reported that a fatal vehicle crash occurred on May 6, 2007 on Old Hanover Road and that speed appeared to be the major factor.

Norma Markle read the Planning Commission report.

Curvin Snyder presented a 2 lot subdivision plan along High Rock Road. This plan was presented with a notation that property is in Heidelberg Township and the Penn Township line was deleted. Tim Hansen made a motion to conditionally approve this plan, pending the Planning Commission's approval of the changes. Larry Sterner seconded and Harry Rodgers concurred.

Brandon Bishard, from Hanover Land Services, presented the Final 4 lot subdivision plan for Bruce Ruhlman (Land Sales & Services) along Packinghouse Road. This plan has been conditionally approved pending posting of a bond and the recreation fee was paid. All matters have been done and they are asking for signatures. Harry advised to check with Steve McKonly and if he is satisfied with everything the plan can be signed.

Brandon Bishard, from Hanover Land Services, presented the Final Plan for Peter Filas for a land swap off of High Rock Road. Tim Hansen made a motion to conditionally approve this plan pending satisfaction is obtained by Steve. John Leen felt the plan was in order. Larry Sterner seconded and Harry Rodgers concurred.

Tom & Cindy Bortner presented their 1 lot subdivision plan along Hilltop Drive. A copy of a "Draft" Deed was presented. Harry Rodgers advised that the Planning Commission needs to sign this before they would approve it.

Scott Rabenstine read the Fire Report. The Department responded to 26 calls for the month. Scott reported that the Department went to the Group Home on Smith Station Road to inspect the facility and they were impressed with the sprinkler system they have and stated they were good to work with.

Norma Markle read the Zoning Officers report. There was \$ 2,037.00 revenue for the month.

John Leen reported that he and Lucas continue to review the Haar subdivision plan.

Tim Hansen made a motion to obtain York County's NIMS training. Larry Sterner seconded and Harry Rodgers concurred.

A review of Steve McKonly's 5/30/07 letter concerning Filing Fees for plans with other municipalities to obtain fees. Tim Hansen made a motion to charge a fee and
