Minutes of the May meetings were approved as distributed.

Officer Jamie Stalcup read the Police Report. There were 62 calls in the township in April.

Ron Lucas, Attorney for Dr. William Prin presented a letter to the board to point out an error in the advertisement of the adoption of the proposed Comprehensive Plan. Mr. Lucas also presented a letter on behalf of Dr. Prin, requesting that his property be rezoned to an all Residential District, they feel this would be consistent with the use there now.
