

The June 1, 2005 meeting of the Heidelberg Township Board of Supervisors was held at the Municipal Building and called to order at 7:30 PM by Chairman Harry Rodgers.

Harry Rodgers, Larry Sterner, Tim Hansen, John Leen, Steve McKonly and Norma Markle were present.

Others present were Dirk Wildasin, Sherri Lockard, Chester Hoke, Robert Diehl, Ronald Lecrone, Scott Rabenstine, Peggy Moulson, Ellen Thompson, Paul Hilbert, Rodney Schriener, Officer Stalcup, Dr. William Prin and Atty. Ron Locust.

Minutes of the May meetings were approved as distributed.

Officer Jamie Stalcup read the Police Report. There were 62 calls in the township in April.

Ron Lucas, Attorney for Dr. William Prin presented a letter to the board to point out an error in the advertisement of the adoption of the proposed Comprehensive Plan. Mr. Lucas also presented a letter on behalf of Dr. Prin, requesting that his property be rezoned to an all Residential District, they feel this would be consistent with the use there now. The Board decided a Special Hearing will be held Thursday June 23, 2005 at 7:30 PM to consider adopting this plan.

Chester Hoke presented a 2 lot subdivision plan for his property along Iron Ridge Road. John Leen and Steve McKonly stated they have not seen this plan before, therefore Harry Rodgers made a motion to table this plan till the July 6, 2005 meeting.

Dirk Wildasin presented his Preliminary Plan, along Gitts Run Road. After reviewing the plan the Board said it could be signed when;  
(a) agreement for common septic system is obtained (b) bonding for street improvements (c) \$ 2,000.00 Recreation Fee is paid.

Scott Rabenstine read the Fire Report. There were 20 calls for the month.

Norma Markle read the Zoning Officers report. There was \$ 972.00 revenue for the month.

John Leen stated that a preconstruction meeting for the roof installation will be held tomorrow. John also stated the retention ponds on Hill Top Drive and Gitts Run Road will be checked into.

Steve McKonly stated he is ready to file the Street Light In. The suit by Dale Myers will be going to the Human Relations Board in the near future and Steve suggested asking Dale if Heidelberg Township can be dropped by that suit.

Larry Sterner stated that Bob Thoman is doing the mowing along the Township roads.

A letter for a 90 day extension for the Richard Stauffer subdivision plan was reviewed and accepted by the Board.

Bruce Jones left a report that stated the Final Inspection of the park will be July 5th, so the balance of the Block Grant can be released for payment.
