The June 4, 2014 meeting of the Board of Supervisors of Heidelberg Township was held at the municipal building and called to order by Chairman Tim Hansen at 7:30 PM.

Members present were Tim Hansen, Larry Sterner, Matt Bollinger, Steve McKonly, Adam Smith and Norma Markle.

Others present were Kris Raubenstine, Chief Bean, Dirk Wildasin and Scott Rabenstine.

Minutes of the May meeting were approved as distributed.

Chief Bean reviewed the April Police Report. Chief Bean asked that the Supervisors send a letter of support to create a broader grant program for the State Gaming Fund for regional police departments.

Norma Markle read the Planning Commission report.

Kris Raubenstine from Hanover Land Services, presentd a Final Land Development Plan for Dirk Wildasin for Lot 5 on Amy Way, to construct a 36x48 storage building for personal use. A letter of credit will be needed for the public improvements. A notation must be added to the plan stating "Future change of use for this lot must seek application for new land development plan" Larry Sterner made a motion to approve this plan pending receiving the letter of credit and notation being added to plan, Matt Bollinger seconded and Tim Hansen concurred.

Norma Markle read the Zoning Officers Report. There was \$750.00 revenue for the month.

Scott Rabenstine read the Fire Report. The Department responded to 18 calls in May. Scott stated the department has done some cutting and trimming in the park.

Adam Smith reviewed the Engineers Report. They will be following up with Penn DOT concerning 1112 Porters Road drainage problem. Adam stated grant money is available for parks and recreation areas within the Township, through the County. Adam presented information on federal mandatory regulations concerning the reflectivity of signs within the Township, which must be in place by June 14, 2014.

Matt Bollinger made a motion to adopt **RESOLUTION 14-02** for Traffic Sign Management as required by the Federal Highway Administration and included in its manual of Uniform Traffic Control Devices. Larry Sterner seconded and Tim Hansen concurred.

Larry Sterner stated he has been mowing along township roads. Larry has also met with Gary Tipton, from PA Municipal Services, and has received project numbers for road improvements to Menges Mill Road and Packinghouse Drive, these projects will be advertised for bids and opened at the July meeting.

A request was made by Dale Myers to add Wendy to his insurance police in September when they are married, this expense would be paid by him. Norma will check with Capital Blue Cross.

Norma Markle read the Treasurers Report.
