The proposed Heidelberg Township Ordinance No. 2025-03 sets the annual compensation for township supervisors entering office after the effective date of the proposed Ordinance and provides for Repealer, Savings Clause, Severability, and an Effective Date.

ORDINANCE 2025-03

AN ORDINANCE OF THE TOWNSHIP OF HEIDELBERG, YORK COUNTY, PENNSYLVANIA, SETTING SUPERVISOR COMPENSATION

WHEREAS, Heidelberg Township, York County, Pennsylvania, (the “Township”) is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 94 of 2024, which sets forth parameters for the compensation of supervisors of townships of the second class, and;

WHEREAS, the Act provides that supervisors of townships having a population of not more than 4,999 may be compensated in an amount not to exceed \$ 3,145 per year and;

WHEREAS, the population of Heidelberg Township is 3,028 per the official US Census of 2020 and does not exceed a population of 4,999; and

WHEREAS, the Board of Supervisors of Heidelberg Township, York County desires to set annual compensation for Township Supervisors in accordance with Act 94 of 2024.

NOW THEREFORE BE IT ENACTED AND ORDAINED, by the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, as follows:

SECTION 1. Each supervisor of Heidelberg Township entering office after the effective date of this Ordinance shall receive compensation as a supervisor in the annual amount equal to \$3,145.00.

SECTION 2. Such compensation shall be paid to Supervisors in quarterly installments of \$786.25.

SECTION 3. Repealer. All provisions of previous Ordinances of Heidelberg Township which are contrary to this Ordinance are expressly repealed.

SECTION 4. Savings Clause. In all other respects, the Heidelberg Township Ordinances shall remain as previously enacted and ordained.

SECTION 5. Severability. The provisions of this Ordinance are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid to be unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses or part of this ordinance.

SECTION 6. Effective Date. This Ordinance shall take effect immediately after adoption in accordance with Section 1601(a.1) of the Second Class Township Code.
