The regular meeting of the Heidelberg Township Board of Supervisors was held March 3, 2004 at the municipal building and was called to order at 7:30 PM by Chairman Harry Rodgers.

Harry Rodgers, Larry Sterner, Tim Hansen, John Leen, Steve McKonly and Norma Markle were present.

Others present were Ed Morin, Jim & Jane Stambaugh, Bruce Jones, Sergent Jack Greene, Chad Kehew, Bradley Herr, Bob Schmeldine and Donald Weaver.

Minutes of the February meetings were approved as distributed.

Bruce Jones stated with the weather breaking they are working on the top part of the park and playground area. Bob Schmeldine is preparing the tax recorders for the Rec. Board. Lacross teams have been filled. A list of rules to be posted at the park will be reviewed by the Board.

Jim & Jane Stambaugh stated they have a water problem at their property on Shutt Road and feel it is caused by the homes on Clinton Court and the other new homes just built on Shutt Road. They said all the water from all the new home runs across their land and is causing erosion problems. Larry Sterner stated he met with Mike Hartman and he is checking on an easement with PH Glatfelter Co. on putting a drain in along the Stambaugh property. The Stambaugh stated something has to be done to ease this problem.

Bradley Herr stated he is trying to subdivide land in an industrial zone and is requesting this land be rezoned back to agricultural. He was told the township is required to have a certain amount of land in the industrial zone within the township. A request for this change and also the Bill Warehime property along Route 116 will be forwarded to York County Planning Commission for their review and comment.

Jim Holley, Chad Kehew and Donald Weaver presented a 3 lot sub division plan for Mr. Weaver. This plan is for a small flow system for the sewage on this lot and all requirements that DEP requires have been met. Harry Rodgers made a motion to conditionally approve this plan pending (a) State Driveway Permit (b) DEP Planning Module approved (c) paragraph 4 of agreement shall state that this system is the owners responsibility (d) Planning Commission signatures. Larry Sterner seconded and Tim Hansen concurred.

Norma Markle read the Planning Commission report.

Correct bonding for the Martz plan is needed before this can be recorded.

Ed Morin read the Fire Company Report. The department responded to 28 calls for the month. A state grant for the fire company for Emergency Services was approved for \$7,000.00.

Norma Markle read the Zoning Officers report. There was \$2,458.00 revenue for the month.

John Leen discussed the Driveway Permit received from PA DOT for the Park.

Larry Sterner stated that the road crew has been doing some patch work and he meet with Mike Hartman concerning some drainage problems along Shutt Road. The quotes for mowers were reviewed, which are all state contracts. Larry Sterner made a motion to purchase a New Holland TC33 tractor with mower for the price of . Tim Hansen seconded and Harry Rodgers concurred.

Bids for the roof of the township building will be bid.

Bids for materials and road improvements will be opened at the April 7, 2004

meeting.

Tim Hansen stated the survey has been sent out for the 10 Comprehensive Plan and a public meeting will be held March 23, 2004 at 7:00 PM at the Fire Company.

Harry Rodgers made a motion to hire Paul Hilbert for building maintance at the cost of \$ 10.80 per hour. Tim Hansen seconded and Larry Sterner concurred.

Harry Rodgers stated that the agreement with Susquehanna Communications is alright to sign.

A Zoning Hearing will be held on March 30, 2004 concerning the cell tower on the Krug property.

Norma Markle read the Treasures Report.
