Others present were Sgt. Jack Greene, Gene & Diana Nace, Jamie Nace, Clay McKim, Doug Stambaugh, Bruce Jones, Tom Feninez, Linus Finicle, Jack Powell, Mr. Beckett, Doug & Wanda Myers, Jim Berkheimer and Don Willey.

Sgt. Green read the March police report. They Department responded to 82 calls in the Township for the month.

Bids were opened for various materials. (See Attached) After review of the bid packets Larry Sterner made a motion to accept the bids as follows;

Bruce Jones reported on the Rec Park, he stated that there has been some vandalism at the park and possibly the police can check things out.

Don Willey a resident of Smith Station Road stated he had spoke to Chief Bean earlier this year concerning speeding along this road and nothing has been done. He would like the police to patrol more often. Sgt. Green discussed with Mr. Willey that a speed test had been completed there and the speeding issue does justify extra patrol. Sgt. Greene suggested that possibly the speed trailer would be available to sit there to show vehicle speed as they pass.

Jim Berkheimer and Wanda Myers residents of the Iron Ridge and Old Hanover Road area of the Township stated they have an excessive fly problem and feel the chicken farm is the cause of the problem. They asked what action will be taken or does the health board or the media need to be contacted. They feel the manure needs to be treated. They said the flies just swarm around their homes, they can't sit out or think about cooking out, fly strips are solid. Who is checking on this? They said Jackson Twp. has a nuisance ordinance for something like this and why couldn't Heidelberg? Jay Little suggested they contact DEP or a local representative. He stated that Section 205.5 of the Zoning Ordinance which is an Agricultural Nuisance Disclaimer doesn't give the Township they authority to address this due to the Pa's Right-To-Farm Act.

Linus Finicle and Jack Powell representing Allen Beckett concerning a 2 lot subdivision along High Rock Road. They feel this is a collector street and low density area and should not require curbing. A decision was made in March to make this a 2 lot subdivision instead of a 3 lot and they are asking to waiver road improvements. The Board feels the curbing needs to be installed because it is in place in other areas of this road. Mr. Beckett would be willing to install a stormwater management plan to help
