No bids were received for gasoline or diesel fuel. Mr. Staley feels the tile drains are clogged and need to be opened, the pit is getting deeper and the water has no where to go. Harry Rodgers suggested that Larry Sterner and Lucas Parkes meet at the site and discuss installing a new pipe. Atty. George Schwartz stated that Mr. Staley is close to signing a agreement with the kennel for installation of their storm water plan. Mr. Staley asked that the engineer check to see if this is done per plan as per the engineer approved.

Norma Markle read the Planning Commission report.

Brian Bankert read the Fire Report. There were 24 calls for the month.

Jay Little read the Zoning Officers report. There was \$ 1,958.00 revenue for the month.

Jay also presented a draft letter for the board to review for the acquisition for the Glatfelter property for a recreation area.

Lucas Parkes reviewed and updated the engineers report.

Steve McKonly presented the draft ordinance for brake retarders for an area of Moulstown Road. The Board will review this document.

Larry Sterner stated the new truck was taken to Hershey for the State Convention and was the talk of the show. Larry will start trimming along the Township roads.

The old truck will be put out for bids at a later time.

Tim Hansen reviewed a quote from Atty. Bryan Salzman for \$5,000.00 for help in completing the Zoning Ordinance update. Larry Sterner made a motion to accept this quote, Harry Rodgers seconded and Tim Hansen concurred.

Hope Baptist Church inquired about volunteering for work to be done within the township. It was suggested to pick up litter along township roads.

Sherry Thompson inquired about attending a Certified Tax Collector Course in October. The cost is \$95.00 for the CD and \$ 50.00 for the test. Tim Hansen made a motion for her to attend this course, Larry Sterner seconded and Harry Rodgers concurred.
