Members present were Harry Rodgers, Larry Sterner, Steve McKonly, Lucase Parkes and Norma Markle.

Others present were Rachel Dill, Paul Hilbert, Officer Linda Duffy, Bruce Jones, Scott Rabenstine, Bob Wark and Peg Moulton.

Minutes of the October 3, 2007 were corrected as follows; Larry Sterner made the motion to give a 45 day extension for all matters to be completed, for the Laurel Summitt II plan, and Tim Hansen seconded. Minutes were then approved as distributed.

Officer Linda Duffy read the Police Report for September. The Department responded to 71 call in the Township. Officer Duffy also read a Thank You from Chief Bean for the use of our building for "Building Clearing" training.

Tom Ruth, from Glatfelter Memorial Library, thanked the Board for their past support of the library and hope it continues. An increase in funding would be greatly appreciated.

Bruce Jones reported the grant approval has been approved and the remaining monies can be released. The driveway has been completed and can be inspected by the state. A half mile walking trail will be the 2008 project.

The 2008 proposed Budget was presented and will be \$840,000.00, up 3.1%. The tax rate will remain at 1.5 mills. The Budget will be advertised for adoption at the December 5, 2007 meeting.

Norma Markle read the Zoning Officers report. There was \$9,528.00 revenue for the month.

Lucas Parkes reviewed the Engineering Report. The road improvements for the Alwine subdivision along High Rock Road need to be completed.

Steve McKonly stated he will advertise the 2008 Budget for adoption at the December 5, 2007 meeting.

Larry Sterner made a motion to adopt **RESOLUTION 07-13** to distribute excess Pension monies to Southwestern Regional Police Department plan. Harry Rodgers seconded.

The Board agreed to close the Index Fun and transfer the monies to the General Fund.

The Board selected Hemler Animal Contral Service for the 2008 contract, this is dealt through the Police Department.

A Treasures Bond, through Travelers Casualty & Surety Company of America, for \$ 150,000.00 was signed by Harry Rodgers for 2008.

A letter dated 10/31/07 from York County Planning Commission was reviewed concerning the 2007 CDBG program for the Porters Sideling Sanitary Sewer, there will be no action taken at this time.

A letter dated 10/15/07 from the York County Board of Commissioners was reviewed concerning a Gypsy Moth Cost-Share Program. The cost for Heidelberg Township would be \$4,794.00. The Board is undecided at this time if to join this program. The number if acres will be reviewed and discussed at a later time.

Paul Hilbert asked if anything was done concerning a Dog Ordinance and he was told this is covered under State Laws and all animals must be on a leash.

Norma Markle read the Treasures Report.
