

The November 7, 2001 meeting of the Heidelberg Township Board of Supervisors was called to order at 7:30 PM at the Heidelberg Township Municipal Building, by Chairman Harry Rodgers.

Harry Rodgers, Guy Brown, Paul Hilbert, Steve McKonly, Scott DeBell, Dale Myers and Norma Markle were present.

Others present were Charles Howard, Ralph Snoots, Larry Sterner, Pat Carey, Bob Schidlein, Bob Finke, Kevin Amoss, Bruce Jones, Chris Trone and John Lingg.

Minutes of the October meetings were approved as distributed.

Charles Howard asked that the Board appoint Ralph Snoot as a Fire Police. He has just completed the needed training. Harry Rodgers made a motion to appoint Mr. Snoot as a Fire Police, Guy Brown seconded, and Paul Hilbert concurred.

Chris Trone is interested in developing land adjacent to Rosepointe and would like to extend the existing cul-de-sac to do so. Steve McKonly recommended that the Board not waive the cul-de-sac length and access to this land would need to come from another area. Mr. Trone suggested a Zoning Hearing on this but this is not a zoning matter and would fall under the Sub-Division and Land Development for the Township. Mr. Trone was interested in forming 6 building lots.

Norma Markle read the Planning Commission Report.

The Board reviewed a 2 lot sub-division plan for Cleo Wildasin along Mill Road and Route 116. The Board tabled the plan pending the set backs along Route 116 are changed to 50' instead of 35'.

A revised plan for Land Sales & Services was reviewed and tabled until the concrete curbs are shown and bonding documents are received.

A plan for GTY mostly in Penn Township was discussed and this plan will need to go through the process in Heidelberg Township also.

Kevin Amoss read the Fire Report. There were 19 calls for the month.

Dale Myers read the Police Report. They traveled 3,796 miles and had 575 hours of service.

Norma Markle read the Zoning Officers report. There was \$ 388.00 revenue for the month.

Scott DeBell discussed the proposed parking area for the park. Scott

will do the recording of Lexus Drive for liquid fuels money and will also review the maintenance agreement.

Steve McKonly explained the documents he received for the Worship Center were in order. Steve also stated that the Supreme Court denied the appeal for Mr. Sterner and suggested that the Board meet with Pete Solymos.

Paul asked if there was a reply from the Vet Hospital, he was told he had not. Paul also asked where the Township stands with no parking in Porters.

Bruce Jones presented the Board with names of the members of the Recreation Committee. The feed that was held last week netted approximately \$ 2,000.00 profit. Paul discussed the lay out of the field and the land on which it is constructed. A meeting will be held Nov. 10, 2001 at the field to discuss this matter.

Harry Rodgers presented the proposed Budget for 2002. The Budget is \$ 695,000.00 and there will be no tax increase. The millage will remain at 1.20 mills but for 2002 the Townships share will be .95 mills and .25 mills to the Fire Company.

Guy Brown made a motion to adopt RESOLUTION 01-12 to amend the Recreation Fee to \$ 600.00. Paul Hilbert seconded, Harry Rodgers concurred.

Guy Brown made a motion to adopt RESOLUTION 01-13 to develop a Comprehensive Plan Updates for Heidelberg and West Manheim Townships for a Regional Policy Plan. Paul Hilbert seconded, Harry Rodgers concurred.

Norma Markle read the Treasures Report.
