Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve the August BOS Meeting Minutes. Motion passed 2-1.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve the Final Subdivision Plan including two requested waivers from Lamplighter Homes/Ruhlman Concrete LLC – 1353 Marburg Road Plan-C-25-010 drawn by Clark Claumer, dated 07-01-2025 and revised 9-3-2025. Proposes subdividing 1 acre with existing dwelling from 9.2-acre lot, allowing to build a future garage/shop on the remaining area of the parcel. Supervisor King called for discussion. Motion passed 2-1.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve Hanover Community Church – 1959 Smith Station Road Final Land Development and Reverse Subdivision Plan. Plan H9810-23 Drawn by SMG, Hanover Land Services dated 1-30-2025 and revised 8-12-2025. Planning Commission recommends approval to the BOS the following waiver requests: S403 – Feasibility Report on Water Facilities S405, 406.E.15-Traffic Study, S504.A&C-Minimum Cartway Width, S507.A-Curbs, Gutters and Walkways and S510.B.12-Driveways and Access Drives. 9. Finance

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve the August Treasurer's Report with the Water Company account correction. Motion passed 2-1.

Supervisor King asked Solicitor Shultis to clarify the Sunshine Law Violation regarding the budget. Solicitor Shultis responded, today is the meeting to discuss the budget, these are the two options the board should consider and discuss publicly. It is not laid out to the public until it is approved by the Township for advertisement for the public.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to authorize the Solicitor to draft an Ordinance to restrict vehicles over 25ft long on Cannery Road. Motion passed 3-0.

Chairman Hansen acknowledged the receipt of High Rock Road Minor Stop Control Study completed by LTAP.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to authorize the Solicitor to update Ordinance 90-4 with the Minor Stop Control stop sign placement from High Rock Road N to High Rock Road W. Motion passed 3-0.

11. Engineer

Chairman Hansen acknowledged the receipt of the October 2025 Engineer Report.

12. Recreation

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve the request from the Recreation Board to allow the board to carry the remaining 2025 balance of \$2,228.45 into 2026. Motion passed 3-0.

13. Water

Chairman Hansen acknowledged Quarter 3 Water Bills – 2 passed due. 1 of them is 2 Quarters behind. Waiting for the Solicitor to advise next step for delinquency

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve the following recommendation from the Water Committee: The following change to the rates of the Heidelberg Water Company effective December 6, 2025:
Quarterly Rate \$250 for up to 8,500 gallons, with \$.02 per gallon of any usage over 8,500.

Supervisor King made a motion to eliminate PIBB Loan and replace with 2-year project. Motion failed due to lack of a second.

Supervisor King made a motion, seconded by Chairman Hansen, to eliminate line painting on Hilltop. Motion passed 3-0.

Chairman Hansen made a motion, seconded by Supervisor King, to table the motion to delay Tar and Chip on Menges Mill and Cannery RD and replace for 2026 Tar and Chip for Thoman Rd from Yingling Rd to 6148 Block of Thoman Rd. the east bound lane only covering the center painted line. Motion passed 3-0.

Supervisor King made a motion, seconded by Vice Chairman Bollinger, to set salary limits for TWP Supervisors IAW PA ACT 94 2024 and authorize Solicitor to advertise. Motion 3-0.

Vice Chairman Bollinger made a motion, seconded by Chairman Hansen, to amend the motion approving the advertisement of the Notice of the 2026 General Fund Budget Option 2 Proposed Budget by increasing the Supervisors Pay amount by \$1,200.00. Motion passed 3-0.

Supervisor King made a motion, seconded by Chairman Hansen, to table the motion until January 2026 BOS Meeting to have the following made into an ordinance or to have them as an amendment to the TWP Zoning Ordinance:

- a. Occupying a Recreational vehicle or camper or tents for more than 15 days in any six-month period is prohibited. A special permit can be issued to extend the time if for the purposes of
 1. Providing health/domestic care to the owner of the property.
 2. A special permit can be issued to extend the time if for the purposes of renovating a house on the same property. The exemption is for the homeowner only
 3. In an agricultural zoning area/district can be granted for farm workers
 4. Connecting a Recreational vehicle to the TWP sewer or water system or to a well or septic system of any property owner of the TWP is prohibited.
- b. Recreational vehicles and campers legally hooked up to existing sewer or septic systems prior to the passage of these provisions is exempt.

Motion passed 3-0.

Supervisor King made a motion, seconded by Chairman Hansen, to authorize the TWP Manager to submit to the BOS for their approval, no later than February 2026 the postings and policies necessary to come into compliance with the RTK law section 504(b)1-4. Motion passed 3-0.

Supervisor King discussed amendment to the former manager, Barbara Krebs, employment agreement and potential violations.

Supervisor King made a motion to amend the December 2024 minutes; the amendment would eliminate the last paragraph. Motion failed due to lack of a second.
