Minutes of the September meeting were approved as distributed.

Chief Bean reviewed the August Police Report. The Department responded to 111 calls within the Township.

Bids were opened for the sale of the 1991 Ford Dump Truck.

Paul Duahart has a safety concern about the Moulstown, Packinghouse Roads and Pine Drive intersection. Yield signs have been installed and have been stolen and/or vandalized. A yield sign will be order for this intersection. Scott Fontana of Rosepointe Way asked for a possible solution to his rain water problems and washing and erosion control onto his property.
