

The October 2, 2002 meeting of the Heidelberg Township Board of Supervisors was called to order at 7:30 PM at the Heidelberg Township Municipal Building, by Chairman Harry Rodgers.

Harry Rodgers, Paul Hilbert, Larry Sterner, Steve McKonly, Scott DeBell, Jack Greene and Norma Markle were present.

Others present were Mr. & Mrs. Terry Orndorff, Dale Myers, Joe Semmelmen, Doug Brodhecker, Pat Carey, Kevin Amoss, Bruce Jones and Bill Gromen.

Minutes of the September 4, 2002 meeting were approved as distributed.

Joe Semmelman publically thanked the Board for a job well done on the road work which was done in the Rosepointe Way development.

Terry Orndorff stated the problem with recreational vehicles on the Markle property on Moulstown Road as escalated. Steve explained that this was use for recreational purposes and the township does not have any authority. Steve suggested that he seek his own legal advice if he feels he is being harrassed.

Bruce Jones stated the Fall Fundraiser will be mailed out which will include raffle tickets and pickets. A feed will be held at Michael's on November 11, 2002.

Doug Brodhecker spoke of his storm water problem on Marburg Road and how to resolve it. Scott will put together an estimate and Larry will meet with Doug for a solution on this problem and who pays what.

Final Sub-Division and Land Development Plans for the Southwestern Regional Police Department were presented. The bond was also presented. Paul Hilbert made a motion to approve this plan and bond, Larry Sterner seconded and Harry Rodgers concurred.

Norma Markle read the Planning Commission report. There was no business brought before them.

Kevin Amoss read the Fire Report. The Department responded to 27 calls last month. Kevin had reviewed the proposed Burn Ordinance and stated it was suitable to him. Steve will advertise this Ordinance for adoption at the November meeting.

Jack Greene read the Police Report. Southwestern Regional Police Department responded to 303 calls in September, of which 74 were in Heidelberg Township.

Norma Markle read the Zoning Officers report. There was \$ 349.00 revenue for the month.

Scott DeBell is working towards bidding Phase II of the park for the end of the year.

Steve McKonly stated the application for Small Game of Chance has been applied for. Steve discussed an exotic animal ordinance.

Larry Sterner discussed a letter received from Bren Kindelsberger on Shutt Road concerning his driveway being washed out. Mr. Kindelsberger suggested that the curbing be removed. Scott and Larry will check into what needs to be done to correct this problem.

Harry Rodgers asked Steve what needs to be done regarding the Building Code. Steve stated nothing at this point because regulations have not been adopted.

Terry Punt will attend our November 6, 2002 meeting.

The Board will review the contract with Hemler's regarding the animal pick-up.
