ORDINANCE 2026-01

AN ORDINANCE OF THE TOWNSHIP OF HEIDELBERG, YORK COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 88-2, AN ORDINANCE ESTABLISHING MAXIMUM SPEED LIMITS ON CERTAIN STREETS, AS AMENDED

WHEREAS, on September 7, 1988, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted Ordinance No. 88-2, An Ordinance Establishing Maximum Speed Limits on Certain Streets; and

WHEREAS, on January 4, 1999, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted an un-numbered Ordinance establishing Maximum Speed Limits on Certain Streets, supplementing Ordinance No. 88-2 by adding additional streets; and

WHEREAS, on January 4, 2010, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted Ordinance No. 10-1 establishing Speed Limits on Yingling Drive and North High Rock Road; and

WHEREAS, the Board of Supervisors wish to amend Ordinance No. 88-2, as amended and supplemented, to update street names and maximum permitted speed on certain roads as indicated below; and

NOW THEREFORE, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacts and ordains as follows:

SECTION 1: The road previously identified as "Hillview Road" from Hoff Road to Kraft Mill Road shall be amended to be identified as "Hoff Road." The road previously identified as "Kraft Mill Road" shall be amended to be identified as "Porter's Road."

SECTION 2: The following roads shall have their maximum permitted speed lowered from thirty-five miles per hour (35 mph) to twenty five miles per hour (25 mph) and Ordinance 88-2 shall be amended accordingly:

- a) Laurel Woods Lane
- b) Rosepointe Way
- c) Trolley Road
- d) Wildasin Drive
- e) Danner Drive
- f) Potter Court

- g) Manor Drive
- h) Tamarind Drive
- i) Yingling Drive
- j) Deer Run Court
- k) Kelly Avenue
- 1) High Rock N, E, W

SECTION 3: The following roads shall be added to Ordinance 88-2 and shall have a maximum permitted speed of twenty-five miles per hour (25 mph):

- a) Acorn Drive
- b) Shellborne Road
- c) Locust Road

- k) Gardener Road
- 1) Laurel Woods Court
- m) Mountain Court

e) Mountain Road o) Gregorey Road p) Laurel Summit f) Clinton Court g) Oakwood Road q) West Side Drive r) Liberty Road h) Faith Way s) Carlton Avenue i) Charity Way j) Hope Way t) Lexus Drive **SECTION 4**: The following roads shall be added to Ordinance 88-2 and shall have a maximum permitted speed of thirty-five miles per hour (35 mph): a) Glatco Lodge Road b) Packing House Road **SECTION 5**: The speed limits set forth and established in Sections 2 thru 4 hereof have been determined in accordance with 75 Pa.C.S.A. §§ 3363 and 6109(10). **SECTION 6:** Repealer. The provisions of Ordinance No. 88-2, as amended and supplemented, which are inconsistent with this Ordinance are expressly repealed to the extent of any inconsistency. SECTION 7: Savings Clause. In all other respects, Ordinance No. 88-2, as amended and supplemented, shall remain as enacted and ordained. **SECTION 8:** Severability. The provisions of this Ordinance are severable, and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provision shall not affect or impair any remaining sections, clauses, or sentences of the same. **SECTION 9: Effective Date.** This Ordinance shall become effective in accordance with law.
