AN ORDINANCE OF THE TOWNSHIP OF HEIDELBERG, YORK COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. _____, TO ADD A STOP SIGN ON HIGH ROCK ROAD W AT THE INTERSECTION OF HIGH ROCK ROAD W AND HIGH ROCK ROAD N.

| WHEREAS, on the Board of Supervisors of Heidelberg Township, |

| WHEREAS, on, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted Ordinance No, An Ordinance establishing the location of stop signs on Certain Streets; and |
| WHEREAS, on, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted an un-numbered Ordinance establishing Maximum Speed Limits on Certain Streets, supplementing Ordinance No. 88-2 by adding additional streets; and |
| WHEREAS, the Board of Supervisors wish to amend Ordinance No, as amended and supplemented, to add a stop sign on High Rock Rd W at the intersection of High Rock Road W and High Rock Road N as depicted in LTAP Technical Assistance Report 24276 dated October 30, 2025 conducted by Logan Schuman; |
| WHEREAS, a copy of LTAP Technical Assistance Report 24276 is attached, labelled "Exhibit A," and incorporated by reference into this Ordinance. |
| NOW THEREFORE , the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacts and ordains as follows: |
| SECTION 1 : A stop sign shall be installed in accordance with Exhibit A on High Rock Road W at the intersection of High Rock Road W and High Rock Rd N. |
| SECTION 2 : The determination to install a stop sign on High Rock Road W has been done in accordance with 75 Pa.C.S. 6109(a)(6) and 75 Pa.C.S. 6109(e). |
| SECTION 6: Repealer. The provisions of Ordinance No, as amended and supplemented, which are inconsistent with this Ordinance are expressly repealed to the extent of any inconsistency. |
| SECTION 7: Savings Clause. In all other respects, Ordinance No, as amended and supplemented, shall remain as enacted and ordained. |

SECTION 9: Effective Date. This Ordinance shall become effective in accordance with law.
