

The September 3, 2008 meeting of the Heidelberg Township Board of Supervisors was held at the municipal building and called to order at 7:30 PM by Chairman Harry Rodgers.

Harry Rodgers, Larry Sterner, Tim Hansen, Steve McKonly, Lucas Parkes, Jay Little and Norma Markle were present.

Others present were Bruce Jones, Scott Rabenstine, Brian Bankert, Matt Bollinger and Kurt Sterner.

Minutes of the August meetings were approved as distributed.

Bruce Jones reported that the Recreation Committee would like to update the playground next year. The trimming has been completed at the park. Bruce stated he has been approached by teams using the lower ball field that the trees are growing and the fans are needing to move to different areas to watch games and there is a concern about safety because of moving and are now in the path of foul balls. Bruce asked the Board to consider that the trees along the dugout area be moved to a different area of the park next year. This request was tabled until next month.

Scott Rabenstine reported at the August meeting that the Fire Company is installing a propane generator. The project total costs are \$ 53,940.00 and there is \$ 26,000.00 available. Matt Bollinger stated he would forward his remaining 2008 fund of \$ 3,500.00 EMA monies to this cause. Harry Rodgers feels the Township should be responsible for some of this costs because the Fire Company can be used by all township residents in the case of an emergency within the township. Larry Sterner made a motion to donate the additional \$ 24,440.00 to the Fire Company to complete this purchase. Tim Hansen seconded and Harry Rodgers concurred.

Larry Sterner made a motion to adopt **RESOLUTION 08-05** for the updated EMA Plan presented by Matt Bollinger. Tim Hansen seconded and Harry Rodgers concurred.

Norma Markle read the Planning Commission report.

Brian Bankert read the Fire Report. The department responded to 24 call for the month.

Matt Bollinger presented the new EMA plan and NIMS adoption process. The Board needs to take the test and must be done on line. Will be checked into.

Jay Little read the Zoning Officers report. There was \$ 3,047.00 revenue for the month.

Zoning Hearing fees will be increased to \$ 500.00 and will state that legal and engineering fees will be paid by applicant. Steve will present a draft for the October meeting.

Lucas Parkes reviewed the Engineering Report.

Steve McKonly reported that the Beckett plan is ready to be signed, the proper security was presented. Steve questioned the updating of the Township Official map and was told this is being done by RETTEW. Steve asked if the Pepo bond was received and he was told it was not.

Larry Sterner reported that road improvement on Laurel Woods Lane has been completed.

The 2008/2009 State Winter Agreement was presented to be signed.
