

The September 6, 2000 meeting of the Heidelberg Township Board of Supervisors was called to order at 7:30 PM at the Heidelberg Township Municipal Building, by Chairman Harry Rodgers.

Harry Rodgers, Guy Brown, Paul Hilbert, LaVerne Becker, Steve McKonly, Dale Myers and Norma Markle were present.

Others present were Dirk Wildasin, Bob Nedzel, Dean Warner, Robert Finke and Nesta Becker.

Minutes of the August meeting were approved as distributed.

Norma Markle read the Planning Commission report.

Dirk Wildasin presented a Sketch Plan for a 4 lot sub division plan along Gitts Run Road. It was recommended that he present this Sketch Plan to the Planning Commission next week and wait to see what Penn Township does concerning sewer hook-up.

A Revised Plan concerning drainage for the new Shutt Road development was reviewed. No action was taken.

A Final 3 lot sub division plan for J. William Warehime, along Route 116 was reviewed. Harry Rodgers made a motion to accept this plan. Guy Brown seconded, Paul Hilbert concurred.

Bob Nedzel, from Group Hanover, presented a Final 2 lot sub division plan for Evelyn Cline on Hill Top Drive - E. The Board feels that Baumgardner needs a driveway permit for the new driveway on this parcel. Harry Rodgers made a motion to accept this plan, under the condition that a new deed is turned over to the Township within 30 days. Paul Hilbert seconded, Guy Brown concurred.

Bob Nedzel presented the Final 2 lot sub division plan for Joe Geiger & ARWCO Corp., along High Rock Road, which some is in Penn Township. Harry Rodgers made a motion to accept this plan. Paul Hilbert seconded, Guy Brown concurred. (Group Hanover will be returning a milar with signatures from both Townships)

Dean Warner read the Fire Report. The Department had 22 calls for the month. Dean stated that the new truck was put into service August 16, 2000.

Dale Myers read the Police Report. The Department traveled 4,015 miles and had 590 hours of service for the month.

LaVerne Becker stated that he sent out letters to home owners along Gitts Run Road regarding sewer hook-up with Penn Township. They were asked to respond by September 30, 2000.

Bids were not advertised for the proposed ball field, because if anything would be done in 2000 grants could be lost in the future.

LaVerne and Guy wish to set up a meeting with Bailey Barnhardt to discuss the proposed work at Porters Road and Thoman Road. PA DOT will furnish the material and the Township will do the work.

Steve McKonly stated that the Street Light Ordinance is ready to go, except for the number of feet from light. This will be researched and advertised for the October meeting.

Steve presented the 1999 Street Light Tax Leins for Harry to sign.

Paul Hilbert questioned if the Danner Drive Cul-de-sac was repaired. He was told this has been completed.

The Spring Grove Area Community Center needs a liaison for their committee to represent the Township. Paul Hilbert made a motion to appoint Harry Rodgers as liaison, Guy Brown seconded.

Harry Rodgers and Guy Brown will be attending a Town Meeting in Jacobus on September 14, 2000, being held by Senator Mike Waugh.

Large Item Pick-Up in the Township will be held October 16 & 17, 2000.

Norma Markle read the Treasures Report.
