

The September 5, 2001 meeting of the Heidelberg Township Board of Supervisors was called to order at 7:30 PM at the Heidelberg Township Municipal Building by Chairman Harry Rodgers.

Harry Rodgers, Guy Brown, Paul Hilbert, Steve McKonly, Scott DeBell, Dale Myers and Norma Markle were present.

Others present were Bruce Jones, Pam Worley, Merle Riley, Dave Shue, Kevin Amoss, Larry Rohrbaugh, Paul King, Matt Bollinger, Pat Carey, Bob Schmidlein, Andy & Bill Brough, Robert Nedzel and Robert Finke.

Minutes of the August meeting were approved as distributed.

Bruce Jones gave an update of the Recreation Committee; (a) applying for grant programs, (b) will be starting field construction this week, (c) has several fund raisers in mind that will be discussed when finalized, (d) would like to see the Recreation Fee raised.

Paul King a 16 year resident of the township who resides on Cannery Road expressed his concern about open burning in the township, especially of plastic items which causes poisonous gases which we then breath. Mr. King presented documentation of some dangers caused by open burning. Mr. King would like to see no open burning in the township and residents need to be educated and would like to speak to the Fire Chief about these concerns. Mr. King stated he can't even have his windows open on nice days because of the smoke from his neighbors burning their garbage. Harry Rodgers stated that the Board needs to study these documents and then make a decision.

Norma Markle read the Planning Commission Report.

Robert Nedzel presented a 3 lot subdivision plan for Romaine Gardner, with the majority of this in Penn Township. Steve and Scott stated that they did not see this plan before. After review of this plan Guy Brown made a motion to conditionally approve this plan, pending approval by Scott at C. S. Davidson. Paul Hilbert seconded, Harry Rodgers concurred.

Andy Brough presented the 3 lot subdivision plan of the William Brough property along Moulstown Road. Comments were not yet received from DEP and after discussion of this, Guy Brown made a motion to conditionally approve this plan pending DEP approval. Paul Hilbert seconded, Harry Rodgers concurred.

Andy Brough thanked the Fire Department for all their assistance during their recent fire loss.

Pam Worley present a Preliminary Plan for Phase II of Land Sales & Services for a 9 lot subdivision along Smith Station and Pamadeva Roads.

This may require curbing and road improvements. The Board recommended that this plan be tabled and an extension be granted for this plan while Scott reviews it and makes a recommendation on what is required.

Kevin Amoss read the Fire Report. There were 19 calls for the month.

Dale Myers read the Police Report. The department traveled 3,815 miles and had 543 1/2 hours of service for the month.

Norma Markle read the Zoning Officers report. There was \$ 459.00 revenue for the month.

Scott DeBell discussed the procedure for the plan submission, a filing deadline needs to be established and a review by the Planning Commission. Scott and Norma will meet to discuss a system to use for this.

Guy Brown stated that the 2 state projects for road work have now been completed.

Paul Hilbert stated that church along Deagen Road is discharging their drainage water onto the road. Guy will check this out.

Paul stated that the paving along Smith Station Road done by PA DOT has caused a drop-off along the road at Cannery & Thoman Roads. He was told that this project is not complete yet.

Paul stated that his neighbor has problems with storm water drainage from his other neighbors property and feels their storm water management plan was not installed properly.

Dave Shue stated he was pleased with the water hook-up system used to fight the recent fire. PEMA will also be holding classes for shuttling water. Dave also asked the the Board send their regards to the fire fighter from Penn Township that was hurt while fighting this fire.

Norma Markle read the Treasures Report.
