Minutes of the August meeting were approved as distributed.

Allen Prittell, a Board member of the Glatfelter Memorial Library thanked the Board for their past support. He stated the library use continues to grow and progressing into the future. He asked for our continued support.

Ed Strausbaugh was given the police departments Stealth State Summary Report of their observation of Jacobs Mill Road. John Leen will also write a letter to Penn DOT.

Paul and Alison Cole would like to move their business (Resurrection Auto Body) to 6741 York Road. They asked the Board if they felt this could be done. Steve McKonly suggested they seek legal counsel and also check with Dave Brown, SEO, concerning the septic system on the property and apply for a Zoning Hearing for a Special Exception.
