1. Call to order

4. Public Comment

Renan Castillo - Asked how much research was done before making the motion to Join YMCA of the Roses. He did explain there is material circulated on line that very clearly states what the organization stands for. He is very disappointed they would proceed with joining this organization.

Paul King - He gave out information on the YMCA of the Roses of York to crate some questions and conversation. He is concerned several YMCA programs allow trangender bathrooms and participation in locker rooms. He tried accessing the Spring Grove Rec Park Boards website, It's nonexistent, and took it down. Due to so many unanswered questions he feels we need more time to get more information before a vote. Second, the topic of naming rights. Who will want to sponsor anything when no events are being held yet. He also said the Eagle Scouts that did volunteer projects are not available for naming. He will be asking for plagues for them paid for by the township.

Michelle G.- Since the YMCA has taken over areas in other parks and the Codorus State Park, They bring full busses of people in to Cordorus and the residents of the community can't use the pool due to pool closure of too many people. The people swim in the lake when signs clearly state no swimming! The YMCA programs cause many problems for the park rangers.

Andy Brough - He was a former Board member of the Hanover YMCA, He feels the YMCA does a lot of good for the community. The YWCA has victim abuse programs and daycare for low income families.

Micheal G. - He has not seen enough information to make a decision as of yet. What is the YMCA of the Roses going to do for us and what will be changing?

Lori VanTassel - She has spoken to many citizens in the community. There are many people who are willing to volunteer at events and write grants. She states that her understanding was that the members of the Rec Park Board got on the board to volunteer in the Rec Park. So she is not understanding why they would be wanting to vote to have the YMCA of the Roses take over the park. She stated this organization is one of the 15 of the new American welcoming centers, this is resettlement.

Meg Powell - She stated the Spring Grove School District already partners with the YMCA of the Roses. She doesn't feel they will come from Harrisburg or anywhere else to our park. Meg believes they cannot tell us to have transgender bathrooms.

Lynn Hoff - Is a retired nurse who worked in York City and states they will come from the city if there are free programs. She instructed the board to tread lightly on this decision.

Ali - speaks about the board members applied to be active members of the community and the board should be doing the work, not paying someone to do it for us. Why do we need outside groups coming in ?

Sandy Stine - she doesn't understand the concern about the Spring Grove Rec YMCA . Kate King was here for a wonderful presentation. She doesn't understand why people have come to the meeting to throw darts at the presentation.

Travis Laughman - Asked Lori Vantassel if the Video of the rec park meeting has been up online yet? Lori answered yes, Travis told people to go watch the meeting to listen to Kate King's presentation, Travis states he believes it is a good idea to join the YMCA of the Roses. Paul King states the questions of the trangenders bathrooms and other issues were not addressed to Kate King at the meeting.
