Resolution #2024-15

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF HEIDELBERG PROVIDING FOR THE EXPENDATURE OF AMERICAN RESCUE PLAN ACT FUNDS

- WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 became law, providing to the Township of Heidelberg (the "Township") a non-competitive federal formula grant from the U.S. Treasury Department (the "Treasury") totaling \$159,358.88, identified as Coronavirus State and Local Fiscal Recovery Funds ("CSLFRF"); and
- **WHEREAS**, on May 17, 2021, the Treasury published an Interim Final Rule for the use of the CSLFRF; and
- **WHEREAS**, on January 27, 2022, the Treasury issued a Final Rule, which modified the regulations contained in the Interim Final Rule; and
- **WHEREAS**, the Final Rule offered a standard allowance for revenue loss of up to \$10 million, allowing recipients to elect a standard amount of revenue loss or complete a full revenue loss calculation; and
- **WHEREAS**, recipients of CSLFRF that select the standard allowance may use that amount in many cases, their full award for government services, with streamlined reporting requirements; and
- **WHEREAS**, on June 15, 2022, by Resolution No. 2022-05, the Township Board of Supervisors elected the revenue replacement standard allowance in accordance with the Final Rule, which equaled the Township's full award amount of \$159,385.88; and
- **WHEREAS**, the Township utilized the CSLFRF funds for normal Township expenses as revenue replacement but now must spend or obligate the remaining funds totaling \$12, 489.86 by December 31, 2024; and
- **WHEREAS**, the Township Board of Supervisors wishes to provide for the appropriation of the remaining CSLFRF funds in accordance with the Final Rule as published by the Treasury.
- **NOW**, **THEREFORE**, be it resolved by the Board of Supervisors of Heidelberg Township as follows:
 - **SECTION 1**. The above recitals are incorporated herein by reference and made a part hereof.

SECTION 2. The Township Board of Supervisors hereby appropriates the remaining \$12, 489.86 as follows:

a. 2025 Quarter 1 Prepayment to Northern York County Regional Police
